

SUMMARY ANNUAL REPORT

FOR GENESIS ENERGY HEALTH & WELFARE BENEFITS PLAN

This is a summary of the annual report of the Genesis Energy Health & Welfare Benefits Plan (Employer Identification Number 80-0321477, Plan Number 505) for the plan year 01/01/2023 through 12/31/2023. The annual report has been filed with the Employee Benefits Security Administration, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

Genesis Energy, LLC has committed itself to pay certain medical, dental, employee assistance, temporary disability and healthcare FSA (medical, dental and vision) claims incurred under the terms of the plan.

Insurance Information

The plan has insurance contracts with National Union Fire Ins. Co. of Pittsburgh, PA, Prudential Insurance Company of America, Vision Service Plan, CuraLink, LLC d.b.a. CuraLink Healthcare and Pre-Paid Legal Services Inc. dba LegalShield to pay certain life, accidental death & dismemberment, vision, temporary disability, long-term disability, employee assistance program, legal services plan and business travel accident claims incurred under the terms of the plan. The total premiums paid for the plan year ending 12/31/2023 were \$2,549,365.

Because they are so called "experience-rated" contracts, the premium costs are affected by, among other things, the number and size of claims. Of the total insurance premiums paid for the plan year ending 12/31/2023, the premiums paid under such "experience-rated" contracts were \$395,444 and the total of all benefit claims paid under these experience-rated contracts during the plan year was \$327,716.

This is a summary of the annual report for Genesis Energy, LLC Profit Sharing & Retirement Savings Plan, Employer Identification Number 80-0321477, Plan No. 014 for the period January 01, 2023 through December 31, 2023. The annual report has been filed with the Employee Benefits Security Administration, U.S. Department of Labor, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

Basic Financial Statement

Benefits under the plan are provided through a trust fund. Plan expenses were \$16,098,161. These expenses included \$98,558 in administrative expenses and \$15,971,957 in benefits paid to participants and beneficiaries and \$27,646 in other expenses. A total of 1,253 persons were participants in or beneficiaries of the plan at the end of the plan year.

The value of plan assets, after subtracting liabilities of the plan, was \$153,685,093, as of December 31, 2023 compared to \$128,081,274 as of January 01, 2023. During the plan year, the plan experienced an increase in its net assets of \$25,603,819. This increase includes unrealized appreciation or depreciation in the value of plan assets; that is, the difference between the value of the plan's assets at the end of the year and the value of the assets at the beginning of the year or the cost of assets acquired during the year. The plan had total income of \$41,701,980, including employer contributions of \$9,849,172, employee contributions of \$8,637,662, other contributions of \$512,266, gains of \$17,622, from the sale of assets, and earnings from investments of \$22,685,258.
